All servers (Gift bearers, altar servers, readers) are timetabled to serve on a rota at Mass at weekends, Holy Days and at other religious events such as Holy Week, Easter, November Novena etc. The service of altar servers at other liturgies and Masses in church e.g. marriages and funerals, is by arrangement with parents and with their school when necessary.
